

Information on Nominees

Dennis Barletta

Dennis was assigned to the 1st Battalion, 52nd Infantry from August 1976 to October 1979, as the 1st Platoon Leader, Bravo Co, 1976 – 1977 and the Battalion S2 from 1977 to 1979. Subsequent as assignments during his 26-year career included 3ID (Intelligence and Surveillance Company Commander, 103rd MI Bn; Assistant Secretary to the General Staff; S2 3rd Brigade; S3 103rd MI Bn; and, Deputy G2); NATO-Central Army Group G2 Executive Officer; the Army Staff (Army Operations Center Intelligence Watch Team Chief; and, Executive Officer, Director of Counterintelligence); Commander, 14th MI Battalion; I Corps, Deputy G2; and the National Geospatial-Intelligence Agency (Executive Officer Science and Technology Directorate; Central Command Operations and Support Team Chief). Following his retirement, he worked for SAIC and BAE Systems as a contractor supporting geo-spatial intelligence programs. Along with Zak Kozak, he has worked to expand membership with 1970s era veterans of the battalion and is serving as the first president of our group.

William (Bill) Burt

Bill was stationed with the 1-52 Infantry from 1984-1985. He served in a line platoon and was also the Delta Company's CO track and jeep driver. - **Term -** Three years from 1 January 2022 to 31 December 2024
- Roles President / Unit history committee (chair)

Dennis was assigned to the 1st Battalion, 52nd Infantry from August 1976 to October 1979, as the 1st Platoon Leader, Bravo Co, 1976 – 1977 and the Battalion S2 from 1977 to 1979. He served as an Intelligence Watch Team Chief in the Army Operations Center and as the Executive Officer to the Director of Counterintelligence, Army Staff, The Pentagon. He was the S2, 3rd Brigade, 3rd Infantry Division, Commander of the Intelligence and Surveillance Company, 103rd Military Intelligence Battalion, and the Assistant to the Secretary of the General Staff, 3ID. Following graduation from the Army Command and General Staff College and the Armed Forces Staff College he was assigned as the Executive Officer to the Assistant Chief of Staff for Intelligence, Central Army Group, NATO. He returned to the 3ID to serve as the S3 of the 103rd MI BN and then as the Deputy G2. He was assigned to Joint Task Force Provide Promise as the Deputy J2. He was the battalion executive officer of 1-52 Infantry and commanding officer of 7-6 Infantry. He served in the Army for 26 years at Fort Bragg, Cambodia, Ft Eustis, and Fort Benning. Dan Gomulak

October 14, 1947 - July 25, 2024



Daniel W. Gomulak passed away peacefully on July 25, 2024 at his family farm in Danbury, Wisconsin. He was 76 years of age and was surrounded by his family.

Dan was born on October 14, 1947, to Mike and Tracy Gomulak. He died in the same homestead where he had been raised with his five siblings.

Dan attended Webster High School where his affinity for running made him a track star. Even though he had broken his leg in an accident as a child, it never seemed to slow him down. After multiple regional championships, Dan made it to the state track meet his

senior year. His best event was a mile.

After graduating from high school in 1965, Dan planned on attending welding school in Superior but instead received a letter from the draft board, calling him up to serve in the US Army. He spent time at Fort Sill in Oklahoma and then at Fort Knox Kentucky before being deployed to Vietnam from December 1967 to July 1969. He had many stories of close encounters and harrowing adventures from his travels abroad. Upon returning home Dan completed a degree in Agriculture, married Diane Sears, took over the family farm, and raised six children. Over the years Dan expanded the dairy, raised beef cattle, and contributed to the building repair of many cabins and homes in the area. He was often called upon by older farmers in the area to help them out whenever and whatever he was needed for. Dan also worked for Phillip Plastics in New Richmond until he retired in 2008 and came back home to the farm.

On September 10, 2015, Dan met his sweetheart and fiancé Jan Hansen on a blind date. They have been inseparable ever since.

Dan was preceded in death by his parents Mike and Tracy Gomulak, Diane Sears as well as his great-granddaughter Claire DePover. He is survived by his fiancé Jan Hansen; his five siblings, Mike (Fern) Gomulak, Judy (Rod) Hopkins, Kate (Jim) Lucas, Steve (Peggy) Gomulak, and Maria (John) Kinneman; his six children, Daniel J. Gomulak, Heather Quist, Matt (Shelly) Gomulak, Mary (Ron) Meyer, Annie (Chris) Shutt, and Michele Fowler: as well as 21 grandchildren and 2 great-grandchildren; along with nieces and nephews and many friends.

A Mass of Christian Burial will take place at 10 AM on August 6, 2024 at St. John's Catholic Church in Webster, Wisconsin.

Donations for 1-52nd Infantry Guidons

1 For those of you who are interested in this sort of thing, 1-52 Infantry was organized under two separate types of infantry battalion organization during our time in Bamberg. One was called ROAD for Reorganization Objective Army Divisions, included HHC, A, B, C and Combat Support Company (CSC). Then after the mid-1980s we reorganized under the Army of Excellence – Division 86 concept which included HHC, A, B, C, D, and E companies. We will purchase 1-52 Infantry guidons for the combination of the two – HHC, A, B, C, D, E and CSC – seven in total.

Succession Roster

All, we are going to try another approach to our Succession Roster. We have a lot of names "below the sheet". These names need to be inserted "above into the sheet" in their correct platoon and job. Below is a list of names from year 1974. Some History

August Dates of Interest

August 1, 1944 - Anne Frank penned her last entry into her diary. "[I] keep on trying to find a way of becoming what I would like to be, and what I could be, if...there weren't any other people living in the world." Three days later, Anne and her family were arrested and sent to Nazi concentration camps. Anne died at Bergen-Belsen concentration camp on March 15, 1945, at age 15.

August 1, 1944 - The Warsaw Uprising began as the Polish Home Army, numbering about 40,000 Polish patriots, began shooting at German troops in the streets. The Nazis then sent eight divisions to battle the Poles, who had hoped for, but did not receive, assistance from the Allies. Two months later, the rebellion was quashed.

August 2, 1776 - In Philadelphia, most of the 55 members of the Continental Congress signed the parchment copy of the Declaration of Independence.

August 2, 1939 - Albert Einstein wrote a letter to President Franklin D. Roosevelt concerning the possibility of atomic weapons. "A single bomb of this type carried by boat and exploded in a port, might very well destroy the

٠,

whole port together with some of the surrounding territory." Six years later, on August 6, 1945, the first Atomic Bomb, developed by the U.S., was dropped on the Japanese port of Hiroshima.

August 3, 1492 - Christopher Columbus set sail from Palos, Spain, with three ships, *Nina*, *Pinta* and *Santa Maria*. Seeking a westerly route to the Far East, he instead landed on October 12th in the Bahamas, thinking it was an outlying Japanese island.

August 5, 1861 - President Abraham Lincoln signed into law the first Federal income tax, a 3 percent tax on incomes over \$800, as an emergency wartime measure during the Civil War. However, the tax was never actually put into effect.

August 6-10, 1787 - The Great Debate occurred during the Constitutional Convention. Outcomes included the establishment of a four-year term of office for the President, granting Congress the right to regulate foreign trade and interstate commerce, and the appointment of a committee to prepare a final draft of the Constitution.

August 6, 1945 - The first Atomic Bomb was dropped over the center of Hiroshima at 8:15 a.m., by the American B-29 bomber *Enola Gay*. The bomb detonated about 1,800 ft. above ground, killing over 105,000 persons and destroying the city. Another estimated 100,000 persons later died as a result of radiation effects.

August 7, 1964 - Following an attack on two U.S. destroyers in the Gulf of Tonkin off North Vietnam, the U.S. Congress approved the Gulf of Tonkin Resolution, granting President Lyndon B. Johnson authority "to take all necessary measures to repel any armed attack against the forces of the United States and to prevent further aggression."

August 7, 1990 - Just five days after the Iraqi invasion of Kuwait, President George Bush ordered Desert Shield, a massive military buildup to prevent further Iraqi advances.

August 9, 1945 - The second Atomic bombing of Japan occurred as an American B-29 bomber headed for the city of Kokura, but because of poor visibility then chose a secondary target, Nagasaki. About noon, the bomb detonated killing an estimated 70,000 persons and destroying about half the city.

August 13, 1961 - The Berlin Wall came into existence after the East German government closed the border between east and west sectors of Berlin with barbed wire to discourage emigration to the West. The barbed wire was replaced by a 12 foot-high concrete wall eventually extending 103 miles (166 km) around the perimeter of West Berlin. The wall included electrified fences, fortifications, and guard posts. It became a notorious symbol of the Cold War. Presidents Kennedy and Reagan made notable appearances at the wall accompanied by speeches denouncing Communism. The wall was finally opened by an East German governmental decree in November 1989 and torn down by the end of 1990.

August 14, 1941 - After three days of secret meetings aboard warships off the coast of Newfoundland, the Atlantic Charter was issued by President Franklin D. Roosevelt and British Prime Minister Winston Churchill. The Charter, a foundation stone for the later establishment of the United Nations, set forth eight goals for the nations of the world, including; the renunciation of all aggression, right to self-government, access to raw materials, freedom from want and fear, freedom of the seas, and disarmament of aggressor nations. By September, fifteen anti-Axis nations signed the Charter.

August 14, 1945 - Following the two Atomic Bomb drops and believing that continuation of the war would only result in further loss of Japanese lives, delegates of Emperor Hirohito accepted Allied surrender terms originally issued at Potsdam on July 26, 1945, with the exception that the Japanese Emperor's sovereignty would be maintained. Japanese Emperor Hirohito, who had never spoken on radio, then recorded an announcement admitting Japan's surrender, without actually using the word. The announcement was broadcast via radio to the Japanese people at noon the next day. The formal surrender ceremony occurred later, on September 2, 1945, on board the USS *Missouri* in Tokyo Bay.

August 14, 1945 - V-J Day, commemorating President Truman's announcement that Japan had surrendered to the Allies.

August 16, 1777 - During the American Revolutionary War, the Battle of Bennington, Vermont, occurred as militiamen from Vermont, aided by Massachusetts troops, wiped out a detachment of 800 German-Hessians sent by British General Burgoyne to seize horses.

August 16, 1896 - Gold was discovered in Rabbit Creek, a tributary of the Klondike River in Alaska, resulting in the Great Klondike Gold Rush.

August 17, 1943 - During World War II in Europe, the Allies completed the conquest of the island of Sicily after just 38 days. This gave the Allies control of the Mediterranean and also led to the downfall of Benito Mussolini and Italy's eventual withdrawal from the war. However, the Germans managed to evacuate 39,569 troops, 47 tanks, 94 heavy guns, over 9,000 vehicles and 2,000 tons of ammunition back to the Italian mainland from Sicily.

August 21, 1959 - President Dwight D. Eisenhower signed a proclamation admitting Hawaii to the Union as the 50th state.

August 24-25, 1814 - During the War of 1812, Washington, D.C., was invaded by British forces that burned the Capitol, the White House and most other public buildings along with a number of private homes. The burning was in retaliation for the earlier American burning of York (Toronto).

Citation

For conspicuous gallantry and intrepidity in action at the risk of his life above and beyond the call of duty. S/Sgt. Bondsteel distinguished himself while serving as a platoon sergeant with Company A, near the village of Lang Sau. Company A was directed to assist a friendly unit which was endangered by intense fire from a North Vietnamese battalion located in a heavily fortified base camp. S/Sgt. Bondsteel quickly organized the men of his platoon into effective combat teams and spearheaded the attack by destroying four enemy- occupied bunkers. He then raced some 200 meters under heavy enemy fire to reach an adjoining platoon which had begun to falter. After rallying this unit and assisting their wounded, S/Sgt. Bondsteel returned to his own sector with critically needed munitions. Without pausing he moved to the forefront and destroyed four enemy-occupied bunkers and a machine gun which had threatened his advancing platoon. Although painfully wounded by an enemy grenade, S/Sgt. Bondsteel refused medical attention and continued his assault by neutralizing two more enemy bunkers nearby. While searching one of these emplacements, S/Sgt. Bondsteel narrowly escaped death when an enemy soldier detonated a grenade at close range. Shortly thereafter, he ran to the aid of a seriously wounded officer and struck down an enemy soldier who was threatening the officer's life. S/Sgt. Bondsteel then continued to rally his men and lead them through the entrenched enemy until his company was relieved. His exemplary leadership and great personal courage throughout the four-hour battle ensured the success of his own and nearby units, and resulted in the saving of numerous lives of his fellow soldiers. By individual acts of bravery he destroyed 10 enemy bunkers and accounted for a large toll of the enemy, including two key enemy commanders. His extraordinary heroism at the risk of his life was in the highest traditions of the military service and reflect great credit upon him, his unit, and the U.S. Army.

Abdominal pain means pain in the stomach or belly area. Everyone has this kind of pain from time to time. In many cases, it goes away on its own. Some types of abdominal pain can be from a serious problem. One example is appendicitis. So it's important to know when to get help.

Causes of abdominal pain

There are many causes of abdominal pain. Common causes in adults include:

- Constipation, diarrhea, or gas
- Stomach and intestine inflammation from a virus or bacteria (gastroenteritis)
- Stomach acid flowing back up into the esophagus (acid reflux)
- Severe acid reflux, called gastroesophageal reflux disease (GERD)
- A sore in the lining of the stomach or small intestine (peptic ulcer)
- Inflammation of the gallbladder, liver, or pancreas
- Gallstones or kidney stones
- Appendicitis
- Intestinal blockage
- An internal organ pushing through a muscle or other tissue (hernia)
- Urinary tract infections
- Menstrual cramps
- Fibroids in the uterus
- Ovarian cysts
- Pelvic inflammatory disease in women
- Endometriosis
- Crohn's disease
- Ulcerative colitis
- Irritable bowel syndrome

Diagnosing the cause of abdominal pain

Your healthcare provider will give you a physical exam. This is to help find the cause of your pain. If needed, you'll have tests. Belly pain has many possible causes. So it may take a little time to find the reason for your pain. Give details about the type of pain you feel. Tell your healthcare provider if it's sharp or dull. Tell them where and when you feel the pain. Tell them what makes it better or worse. And tell them if you have other symptoms such as:

- Fever
- Tiredness
- Upset stomach (nausea)
- Vomiting
- Changes in bathroom habits
- Blood in the stool or black, tarry stool
- Unexpected weight loss

Tell your healthcare provider:

- If you have a family history of stomach or intestinal problems or cancer
- About your alcohol use and any illegal drug use
- All medicines you take, both prescription and over-the-counter
- What vitamins, herbs, and other supplements you take

Treating abdominal pain

Some causes of pain need emergency medical care right away. These include appendicitis or a bowel blockage. Other problems can be treated with rest, fluids, or medicines. Your healthcare provider can give you instructions. You may need treatment or self-care based on what's causing your pain.

If you have vomiting or diarrhea, sip water or other clear fluids. When you're ready to eat solid foods again, start lightly. Eat small amounts of easy-to-digest, low-fat foods. These include applesauce, toast, or crackers.

Call 911

Call 911 right away if you:

- Can't pass stool and are vomiting
- Are vomiting blood
- Have bloody diarrhea or black, tarry diarrhea
- Have chest, neck, or shoulder pain
- Feel like you might pass out (faint)
- Have pain in your shoulder blades and nausea
- Have sudden, severe belly pain
- Have new, severe pain unlike any you've felt before
- Have a belly that is rigid, hard, and hurts to touch

When to call the healthcare provider

Call your healthcare provider or seek medical care right away if you have any of these:

- Pain that's worse or not getting better
- Bloating that's worse or not getting better
- Diarrhea that's worse or not getting better
- Fever of 100.4°F (38°C) or higher, or as advised
- Weight loss for no reason
- Continued lack of appetite
- Blood in your stool

How to prevent abdominal pain

Here are some tips to help prevent abdominal pain:

- Eat smaller amounts of food at each meal.
- >Don't eat greasy, fried, or other high-fat foods.
- Don't eat foods that give you gas.
- Exercise regularly.
- Drink plenty of fluids.

To help prevent GERD symptoms:

- Quit smoking.
- Reduce alcohol and foods that increase stomach acid.
- Don't use aspirin or nonsteroidal anti-inflammatory drugs (NSAIDs).
- Lose excess weight.
- Finish eating at least 2 hours before you go to bed or lie down.
- Raise the head of your bed.


